On August 7, 2025, the U. Department of Commerce (Commerce) announced the initiation of antidumping duty (AD) and countervailing duty (CVD) investigations of crystalline silicon photovoltaic cells, whether or not assembled into modules (solar cells) from India . On August 7, 2025, the U. Cells and modules from Vietnam, Malaysia, Thailand and Cambodia are affected. Importers have already been posting cash. A letter from the American Alliance for Solar Manufacturing said the U. Trade Commission must act quickly to ensure tariff rulings are in place before a temporary gap creates an opportunity for solar components to be imported duty-free. solar manufacturers (Convalt Energy, First Solar, Meyer Burger, Mission Solar, Qcells, REC Silicon and Swift Solar), petitioned the U. Department of Commerce (DOC).
