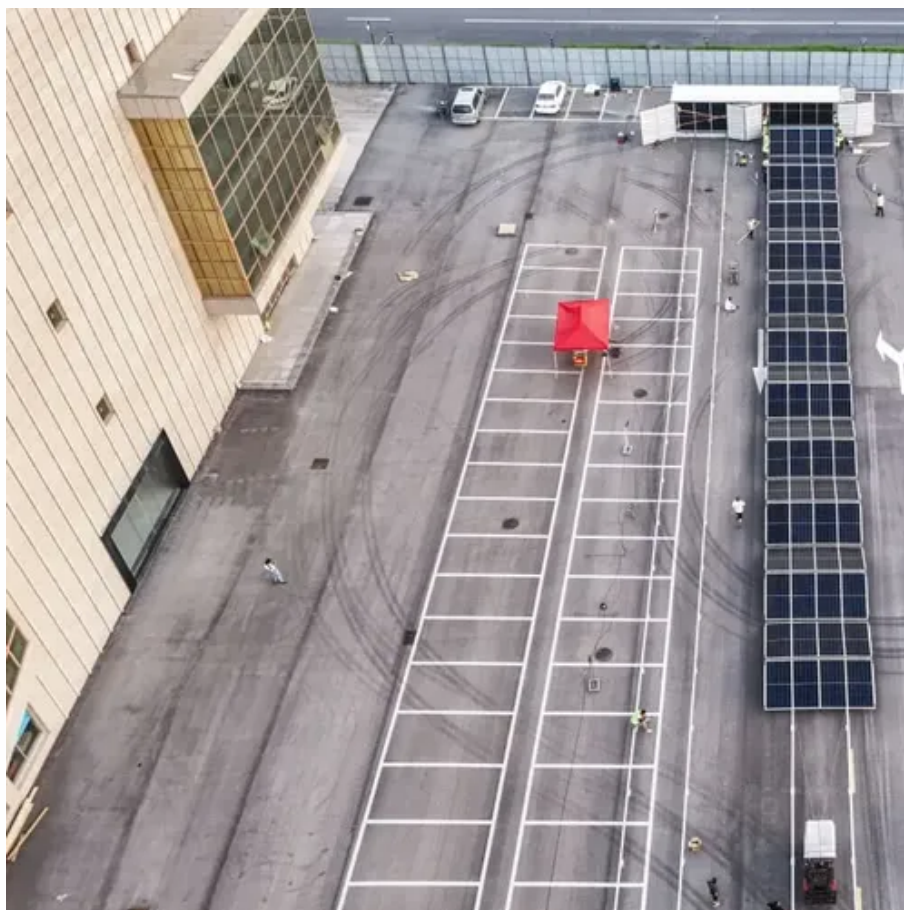




Base Station Energy Management System Installation Subcontracting Plan





Overview

The following outline meets the minimum requirements as imposed by Section 8(d) of the Small Business Act, and meets the minimum requirements of the Federal Acquisition Regulation (FAR) Subpart 19. This model plan is intended to be used as a guideline. (a) Each subcontracting plan required under 19. 702 (a) (1) (i), (ii), and (iii) shall include- (1) Separate percentage goals for using small business (including ANCs and Indian tribes), veteran-owned small business, service-disabled veteran-owned small business, HUBZone small. The purpose of this guidance is to provide uniform direction to the Department of Energy (DOE) personnel and its major prime contractors¹ in order to assist them in utilizing “best practices” in their pursuit of a comprehensive and successful subcontracting program. The Federal Energy Management Program Checklist provides federal agencies with a standard set of tasks, questions, and reference points to assist in the early stages of battery energy storage systems (BESS) project development.
