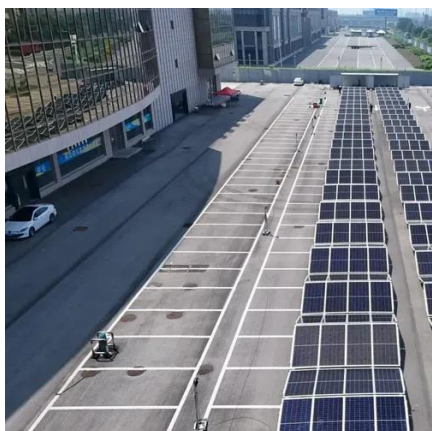


Overview

Manufacturers of qualified energy property must register to qualify products for the Energy Efficient Home Improvement Tax Credit. Property acquired and installed in 2025 must be acquired from a Qualified Manufacturer. In 2011, California adopted a Renewable Portfolio Standard (RPS) requiring that at least one-third of the state's electricity come from clean energy sources by 2020. A qualified manufacturer (QM) under 25C (h) (3) is a manufacturer of that enters. 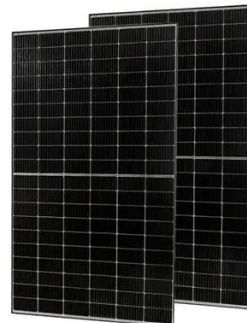
