## Overview

---

This project represents the largest proposed onshore wind energy facility in North America; when fully operational; the project will be capable of generating up to 3,000 megawatts of clean, renewable power, enough to power nearly one million homes. Fish and Wildlife Service has a goal to maintain stable or increasing breeding populations for both bald eagles and golden eagles. The Service may authorize the "take" of eagles, but only where the take is compatible with the preservation of bald and golden eagles, and the take is. Beginning April 12, 2024, USFWS will offer a general permit application for incidental take of bald and golden eagles for wind energy and power line projects. 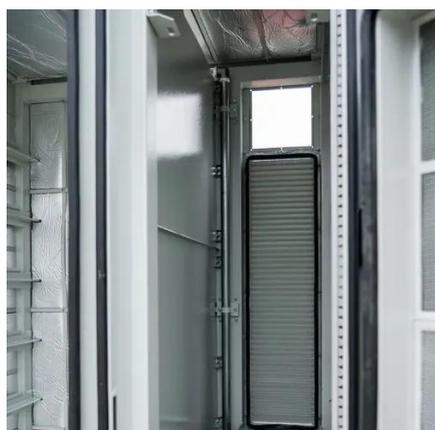


