Starting January 1, 2020, if you're building a single-family home, a townhouse, or a low-rise multifamily building (three stories or less), solar panels are mandatory. No exceptions, no wiggle room. At the heart of this solar revolution is the California Solar Panel Mandate, officially known as Title 24, which has fundamentally transformed how new buildings are constructed in the Golden State since 2020. California leads in renewable energy, committed to sustainable practices and reducing greenhouse gas emissions.
