




Milan Italy to add 376MWh of solar container lithium battery energy storage by 2025





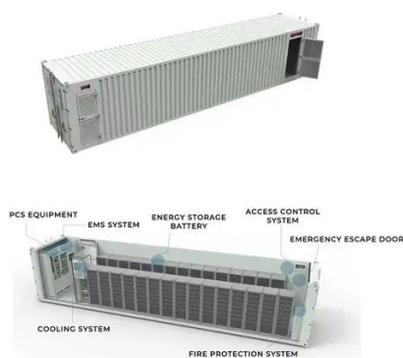
Overview

Across three auction rounds, MACSE aims to support up to 50 GWh of storage capacity. Award 15-year fixed revenues, plus a 20% share of ancillary services.

Milan, July 3rd, 2025 – In Italy, ContourGlobal, a KKR company led by President and CEO Antonio Cammisecra, is establishing itself as a leading developer of battery energy storage systems (BESS). Over the past months, the company has acquired BESS projects with a combined power capacity of. 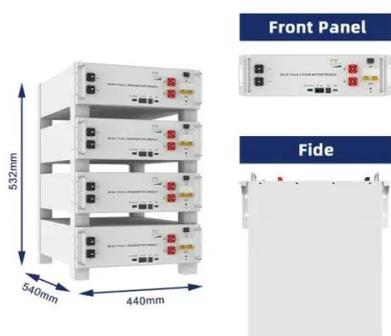

By 2030, Polimi estimates that Great Britain and Italy will have the largest installed battery capacity and will together account for almost 50% of the total capacity growth in Europe.

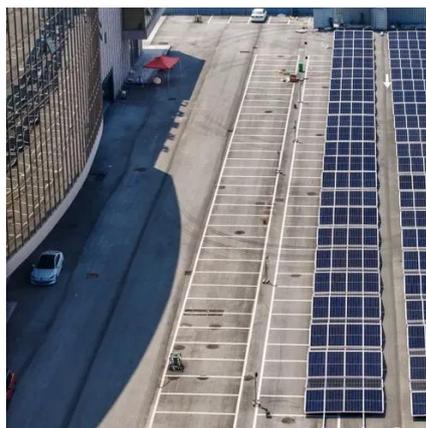

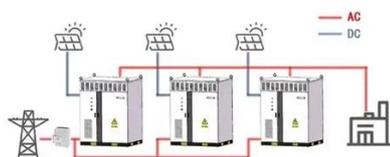
