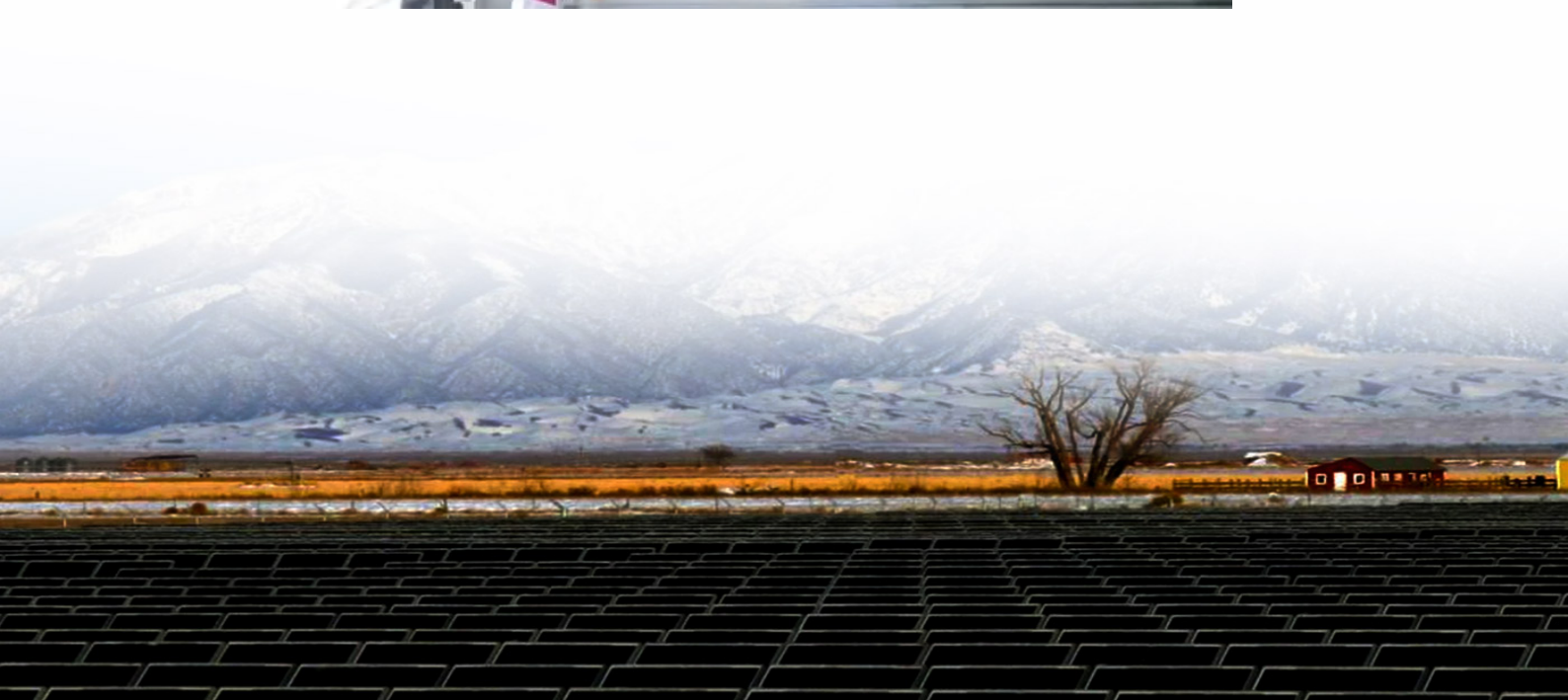

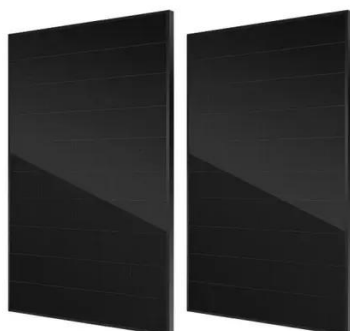


Overview

Solar construction prevailing wage payroll introduces more classification, fringe, and reporting complexity than most traditional construction projects. Payroll teams supporting solar jobs must manage evolving labor classifications, mixed scopes of work, and heightened audit attention while still. The median annual wage for solar photovoltaic installers was \$51,860 in May 2024. Employment of solar photovoltaic installers is projected to grow 42 percent from 2024 to 2034, much faster than the average for all occupations. labor landscape, ensuring that construction workers receive fair compensation for their efforts on government-funded projects.

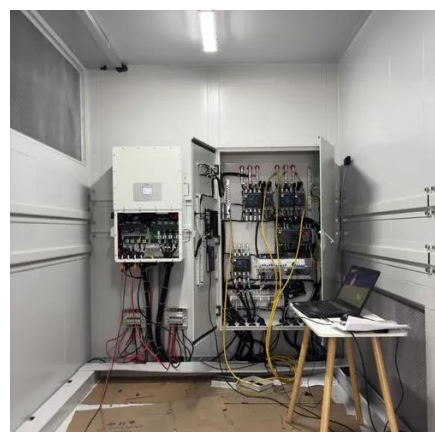
