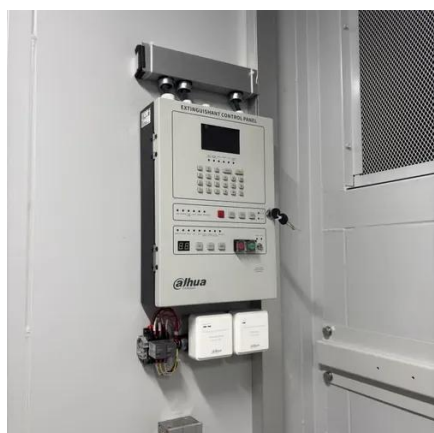

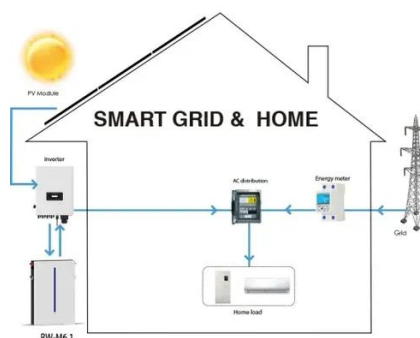

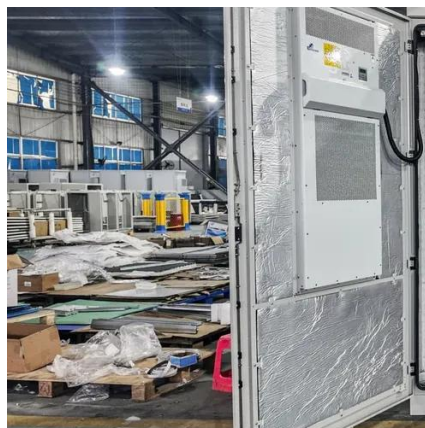


## OUTPATIENT HOSPITAL SERVICES PAYMENT SYSTEM
