Overview

The Residential ITC will end for systems not placed in service by December 31st, 2025. Systems must be installed, inspected, and operational by the cutoff — not just contracted. Answering the Important Questions Update: As of July 4, 2025, the solar tax credit (or Investment Tax Credit, ITC) is scheduled to expire on Dec. The bill, also known as the. CUB Q&A: Solar and EE tax credits are being phased out—so what now?

In July, Congress passed H. 1, the federal budget reconciliation bill. Unfortunately, the sweeping legislation phases out a series of clean energy tax credits. State-specific programs and utility rebates (another solar incentive) will now play a larger role in calculating upfront savings, as will rising utility electric rates.

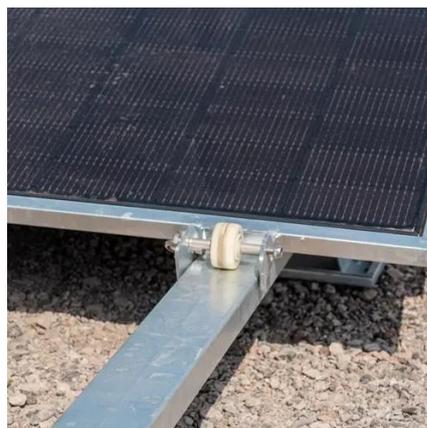
